I am a proud Turrabul and Yuggera woman, living near the Glass House Mountains. My parents have a few acres there, which I was fortunate enough to grow up on.

My parents always remind me that ever since I was a young girl, I wanted to become Lawyer. I always had a passion for the law and helping others in the legal field. This is why in High School I studied legal studies. Upon graduating from St Columban's College in 2018, I began studying a Bachelor of Criminology and Criminal Justice at Griffith University.



In 2020, after one year of studying, I added a Bachelor of Laws. As I was the first person in my family to go to University, I was advised to ease into my degree as I would be paving the way for myself.

Why did you apply for the clerkship?

I applied for the summer clerkship at Gilshenan and Luton because I wanted to gain experience in a criminal law firm. I always had dreams of becoming a criminal lawyer, so I thought it would be beneficial to gain exposure to a criminal firm before finishing my degree. Another reason I applied was because I had heard many great things about G&L, including the work they do and staff they have. I knew G&L were leaders in criminal law, and I wanted to have the opportunity to learn from the best.

What did you do during your clerkship?

The question should be what I didn't do during my clerkship. During my four weeks at G&L I participated in a wide range of legal tasks. Many of which only admitted solicitors get exposure to.

Some of the opportunities I was part of included observing District Court sentences, participating in a week-long trial in the District Court, assisting two senior associates in a joint coronial inquest, going to the cells under the Supreme Court, observing client conferences, writing statements and so much more. During these various tasks, I gained a better understanding of how the different court systems work, the different approaches to advocacy, and the importance of ethics during everything you do as a lawyer.

I also participated in numerous legal workshop sessions. These one-on-one sessions provided me with a deeper understanding of the legal industry, how to write and prepare briefs for counsel, how to effectively research, and the ethical obligations placed on lawyers.
